

### Clinical Policy: Short Inpatient Hospital Stay

### **Description**

Medical necessity criteria for day one and day two of an inpatient hospital stay, excluding behavioral health and obstetrical delivery admissions.

Observation care is a well-defined set of specific, clinically appropriate services, which include ongoing short term treatment, assessment, and reassessment before a decision can be made regarding whether patients will require further treatment as hospital inpatients or if they are able to be discharged from the hospital.<sup>3</sup>

#### Policy/Criteria

**I.** Observation stay: If a physician orders an eligible recipient to remain in the hospital for less than 24 hours, the stay is not covered as inpatient admission, but is classified as an observation stay. An observation stay is considered an outpatient service.<sup>5</sup>

It is the policy of Western Sky Community Care that inpatient hospital stays (vs. observation) of 24 hours or less are medically necessary for one of the following indications:

- The eligible recipient dies;
- Documentation in medical records indicates that the eligible recipient left against medical advice or was removed from the facility by his legal guardian against medical advice;
- An eligible recipient is transferred to another facility to obtain necessary medical care unavailable at the transferring facility; or
- An inpatient admission results in delivery of a child.
- **II.** It is the policy of Western Sky Community Care that inpatient hospital stays (vs. observation) of over 24 hours to less than 48 hours or less are medically necessary for one of the following indications:
  - Admission is for a procedure on the CMS Inpatient Only List, (found here);
  - Admission to an intermediate or intensive care unit level of care (including neonatal intensive care unit (NICU) considered medically necessary per a nationally-recognized clinical decision support tool;
  - Unexpected death during the admission;
  - Departure against medical advice from a medically necessary (per a nationally-recognized clinical decision support tool) inpatient stay;
  - Transferred from another facility, with a medically necessary (per a nationally-recognized clinical decision support tool) total length of stay greater than 2 days;
  - Election of hospice care in lieu of continued treatment in hospital.

### **Background**

Expectation of time and the determination of the underlying need for medical care at the hospital are supported by complex medical factors such as history and comorbidities, the severity of signs and symptoms, current medical needs, and the risk (probability) of an adverse event occurring during the time period for which hospitalization is considered.<sup>1</sup>

Observation services are commonly ordered for patients who present to the emergency department and who then require a significant period of treatment or monitoring in order to make a decision concerning their admission or discharge. The decision whether to discharge a patient from the hospital following resolution of the reason for the observation care, or to admit the patient as an inpatient, can be made in less than 2 days and usually in less than 24 hours. In only rare and exceptional cases do reasonable and necessary outpatient observation services span more than 2 days.<sup>3</sup>
